INTRODUCTION:

Osun is a State in Nigeria with over five million (5,000,000) population spread across thirty-one (31) local government area faces numerous challenges in delivering comprehensive and effective healthcare services to its population. Limited funding, inadequate infrastructure, and a high burden of diseases have led to poor health outcomes and disparities in access to quality healthcare. To address these issues, Tayo Olawoye Foundation has developed this proposal outlining the interventions required to achieve significant improvements in the state's healthcare system thereby seeking world fund support from the Tony Elumelu Foundation to enhance healthcare programme in Osun State, Nigeria.

Tayo Olawoye Foundation aims to improve healthcare accessibility, affordability, and quality for all citizens of the state. According to State Social Health Insurance Agency (SSHIA), the enrollment data 2023 revealed that just 255,154 which is about four percent of the entire population of the Osun state are fully enrolled with OSHIA. This statistic comprises enrollees from Formal sector, Informal Sector, Students in Tertiary Institutions and the vulnerable as represented below: **Total estimated population in the state 5,500,000**

Therefore, this proposal outlines project details, objectives, implementation strategies, expected outcomes, and budgetary requirements that could be of great assistance to the citizen of Osun state.

PROJECT OBJECTIVES:

- To increase health insurance coverage and access for low-income individuals and vulnerable populations in Osun State.
- To strengthen primary healthcare systems by improving infrastructure, equipment, and human resources.
- To develop disease prevention and health promotion initiatives to combat prevalent healthcare issues and reduce the burden of communicable and non-communicable diseases.
- To enhance emergency and specialized healthcare services to cater to the diverse healthcare needs of the population.
- To provide financial protection against catastrophic health expenditures for households in Osun State.

PROJECT IMPLEMENTATION STRATEGIES:

- 1. **Partnerships and Collaboration:** Tayo Olawoye Foundation will collaborate with relevant stakeholders, including the government, local communities, health facilities, and NGOs, to ensure effective project execution.
- 2. **Health Insurance Reform:** Tayo Olawoye Foundation will undertake necessary reforms in health insurance policies, regulations, and management systems to promote universal health coverage and address barriers to enrollment.
- 3. **Infrastructure Development:** Funds will be allocated to renovating, constructing, and equipping primary healthcare centers, hospitals, and

- emergency facilities to ensure adequate and functional healthcare infrastructure.
- 4. **Health Workforce Development:** Training programs, workshops, and capacity building initiatives will be organized to enhance the skills and knowledge of healthcare professionals in Osun State.
- 5. **Community Engagement and Awareness:** Tayo Olawoye Foundation will conduct extensive public awareness campaigns to encourage community participation, educate citizens about the benefits of health insurance, and promote healthy living practices.

EXPECTED OUTCOMES

- a. Increased health insurance coverage from the current coverage of 4.1% to at least 70% of the population in Osun State.
- b. Improved primary healthcare system with upgraded facilities, increased human resources, and enhanced service delivery.
- Reduction in the prevalence of communicable and non-communicable diseases through effective disease prevention and health promotion initiatives.
- d. Enhanced emergency and specialized healthcare services, reducing the need for medical tourism outside the state.
- e. Reduced financial burden on households due to catastrophic health expenditures.

BUDGETARY REQUIREMENTS

The project budget is estimated at five million USD (\$5,000,000), which will be allocated as follows:

- Infrastructure Development: 20%

- Health Workforce Development: 10%

- Health Insurance Reform: 25%

- Disease Prevention and Health Promotion Initiatives: 25%

- Emergency and Specialized Healthcare Services: 20%
